The Applicant agrees that if the proper corporate name and jurisdiction are not provided, or the Applicant corporation does not continue to exist or remain in good standing, that Sarjeant may claim repayment from the person signing this Application;
4. The information given in this Application is warranted to be true and accurate and is given primarily for the purpose of obtaining credit from Sarjeant. The Applicant acknowledges that Sarjeant is relying on the information provided in deciding whether and to what extent to grant credit. The Applicant consents to the collection and use of credit and or personal information as may be required in connection with the credit being applied for and any renewal or extension thereof. The Applicant consents to the use and disclosure of any trade information and personal information concerning the Applicant undersigned to any credit reporting agency or to any person with whom the undersigned has or proposes to have financial relations;
5. If credit privileges are extended, I/we agree to abide by the terms of sale established by Sarjeant in relation to any such sale;
